

Types of Glynn Family Honors Program Grants for the Academic Year

1.) Conference Presentation Grant (CPG)

The Conference Presentation Grant supports travel to conferences for students who are authors on a presentation (e.g., paper or poster). This grant does not support attending conferences at which the student is not a presenter. This can include a presentation at major conferences, regional conferences, and those designed to feature the research of undergraduates. CPG proposals should include: 1) a description of the conference, specifying the particular session or panel at which the student will present, 2) a copy of the accepted abstract, and 3) a letter of support by a faculty supervisor who is a regular faculty member in the College of Arts and Letters (that is, teaching-and-research faculty or special professional faculty). All applicants whose proposals require international travel must submit a travel approval form in order to be considered for a Glynn Honors Program grant. For domestic travel, students will need to complete a domestic travel waiver (see the “Requirements” PDF for more information about international and domestic travel).

The **maximum amount of this award is \$1500***. A copy of the paper or poster presented must be submitted to The Glynn Honors Program within 30 days of the presentation’s completion.

The CPG is open to all sophomores, juniors, and seniors who have a major or minor in a department within the College of Arts and Letters. If there are multiple authors on a poster or paper, we can support up to two, assuming both are recommended by their faculty advisors. As we cannot evaluate the relative contributions of multiple authors, we ask that you make decisions concerning who will present at a given conference in concert with your co-authors.

2.) Research & Materials Grant (R&MG)

The Research & Materials Grant supports materials required for research activities such as: books, payment of participants, software, travel, and meals. Funds are not to be used for equipment such as tape recorders, video or computer equipment, and Glynn will not reimburse for the purchase of those items. The Research and Materials Grant is open to all sophomores, juniors, and seniors who have a major or minor in a department in the College of Arts and Letters.

Applications for this grant need to include: a project description (i.e. statement of the research or creative work proposed), a budget, and a letter of endorsement from the supervising faculty member supervisor who is a regular faculty member in the College of Arts and Letters (that is, teaching-and-research faculty or special professional faculty).

The maximum amount of this award is \$1,750.00*. A final report of the research project must be submitted to The Glynn Honors Program within 30 days of your project's completion.

The R&MG is open to all sophomores, juniors, and seniors who have a major or minor in a department within the College of Arts and Letters.

3.) Senior Thesis Grant (STG) (Large and Small)

The Senior Thesis Grant supports research projects conducted to fulfill the requirements for a senior thesis. To be eligible for this grant, a student must be in his or her junior or senior year (please note seniors must apply before their final semester). The maximum amount for the **Senior Thesis Large Grant is \$2,250***; the maximum amount for a **Senior Thesis Small Grant is \$1,125**. Senior Thesis Small Grants are intended for preliminary senior thesis research. Eligible students may receive two Senior Thesis Small Grants or one Senior Thesis Large Grant. A final report of the research project or a copy of the senior thesis must be submitted to The Glynn Honors Program within 30 days of the project's completion or by May 13 for graduating seniors.

The STG is open to all juniors, and seniors who have a major or minor in a department within the College of Arts and Letters. A letter of support by a faculty supervisor who is a regular faculty member in the College of Arts and Letters (that is, teaching-and-research faculty, research faculty or special professional faculty) must accompany the application.
